### CINCINNATI METROPOLITAN AREA

Movement is authorized during daylight hours, 7 days per week. See attached Limitations/Provisions Form OS-1A for additional holiday(s)/holiday weekend(s) restrictions.

Only the original permit issued by the Ohio Department of Transportation will be recognized as being valid. Copies are not acceptable. However, this letter may be reproduced and must be carried with your valid permits.

Permission to travel County or Township Roads or City Streets not part of the State Highway System must be obtained from the proper authorities. Separate Special Hauling Permits must be obtained for travel on State Highway System routes other than those specified above.

Permittee is responsible to check the route for abnormal, changed, or unknown conditions which may exist during any move.
